GENERAL

The purpose of the “ISF Artistic Gymnastics Technical Rules and Regulations” is to provide standardized rules and regulations for Artistic Gymnastics competition. This document is set up in accordance with the ISF Statutes, the ISF Sport Policy, the ISF General Competition Regulations and FIG Rules.

This document is intended to ensure that all matters related to competitions are conducted in a fair and orderly manner. The specific objectives of this document are to:

1. Define and specify the **general conditions** under which participants can take part in the ISF Artistic Gymnastics events;
2. Determine the **delegation composition**;
3. Determine the **sport programme**;
4. Determine the **technical rules**;
5. Set the **draw** procedure;
6. Set **protests and appeals** procedures.

Please note that the technical rules and regulations apply to the Artistic Gymnastics ISF event in 2025.

1. GENERAL CONDITIONS

The competition will be run according to the ISF rules and regulations, and FIG (International Gymnastics Federation) technical rules under the direction of the FIG. Any decisions over matters not mentioned in the present document will be taken by the FIG Technical Delegate and ISF Artistic Gymnastics Technical Commission.

- The ISF Artistic Gymnastics events are open to individuals/teams.
- The competition is categorized as: girls categories/boys categories.

2. DELEGATION COMPOSITION

Each delegation will consist of:

- Head of delegation - mandatory
- Deputy Head of Delegation - optional
- Student athlete(s) - mandatory
- Team officials (Coach) - mandatory
- Field of Play Officials (judges) - mandatory
- Additional adults - optional
- Safeguarding officer - optional
- Young reporter - optional

HEAD OF DELEGATION (HOD)

- There is a mandatory amount of one (1) head of the delegation per registering delegation.
- The head of the delegation shall be the sole intermediary between the delegation and the Local Organising Committee, and the ISF.
- He/she may not combine the function with any other official role (i.e., coach, etc.).

DEPUTY HEAD OF DELEGATION (Deputy HoD)

- The role of Deputy HoD is to assist the Head of Delegation.
- The presence of the Deputy HoD is not mandatory.
- max 1 Deputy Head of a delegation from 100 to 200 participants.
- max 2 Deputy Heads of a delegation from 201 or more participants.

ATHLETES

- All student-athletes must be enrolled as full-time students at a school in the country in which they represent.
- All student-athletes must be attending schools that provide general education and/or vocational education incorporating segments of general education.
- Only athletes, registered on the team's list/ delegation handed in at the accreditation, are authorized to take part in this competition.
- All athletes must have a valid FIG license which is valid till the end of the competition.
- The team is composed of 3 to 5 athletes.
- Athletes who have competed in a Senior Age category in an official FIG event may not participate in the Gymnasiade.

The following are *not* eligible to participate:

- Attendees of vocational schools only attend a school as a complement to their vocational training and are not full-time students with a segment of general education.
- Students enrolled at schools that provide sports training without any general education.

TEAM OFFICIALS

COACHES

- The presence of a coach is mandatory.
- Teams or individuals cannot participate in the competition without the presence of a coach.
- Each delegation shall enter a minimum of one (1) coach per team (in case of more than one coach for girls, at least of them must be a women).
- Maximum one coach per gymnast.
- Coaches must have the valid FIG coach profile.

OTHER TEAM OFFICIALS

- The function of other team officials can be: doctor, trainer, physiotherapist, statistician, team manager etc.
- The presence of the other team officials is not mandatory.
- The function of the other team officials must be specified during the registration process.
- Any person not specified during registration or exceeding the limit will not be considered part of the team.

FIELD OF PLAY OFFICIALS

- The field of play official (judge) cannot combine their position with any other positions, such as heads of delegation, team officials or additional adults.
- Delegations must provide certificates for judges during the registration process.
- Failure to provide the required number of judges will lead to a fine of 900€ (per judge) payable to the organiser prior to the competitions.
- All judges must have a valid FIG brevet (Category 1-2-3 or 4).

Judges division - MAG :

- Individual: 1 or 2 athletes = 1 judge
- Team : 3-5 athletes =2 judges
- Participating in both = 4 judges

Judges division - WAG :

- Individual: 1 or 2 athletes = 1 judge
- Team : 3-5 athletes =2 judges
- Participating in both = 4 judges

ADDITIONAL ADULTS

- The function of additional adults can be: interpreter, security personnel, ministry representatives, media, etc.
- The presence of additional adults is not mandatory.
- The function of each additional adult must be specified during the registration process.
- Any other additional person not specified during registration or exceeding the limit specified in this document will not be considered part of the official delegation and will not be accredited by the LOC.

SAFEGUARDING OFFICER

The role of the safeguarding officer is to provide support to the delegation in any situation related to safety.

YOUNG REPORTER

Each delegation may bring additional young students who will take the role of a young reporter during the ISF event.

3. SPORT PROGRAMME

EVENTS

- **Boys and Girls**
 - **Team**
 - **Individual**



FORMAT

- The competitions will be conducted according to FIG's Technical Regulations 2025 including Section 2 for Artistic Gymnastics, Reg. 5.1, with the following modifications.
- The competition consists of Qualifications, Team Final, All-Around Final and Apparatus Finals.
- Qualifications will serve as the qualifications for the Apparatus Finals.
- Team and All-Around Finals results will be determined by results of Qualifications.
- All the delegation are entitled to participate either with a team of 3 to 5 gymnasts or with a maximum of 2 Individual gymnasts.

- And subsequent decisions of the FIG Executive Committee.



SPECIFIC RULES

- WAG & MAG : 2025 – 2028 FIG code of Points : Junior Rules.
- All Around Finals : ranking with only 2 gymnasts per country.

TEAMS FINALS

- 5 gymnasts in the team – 4 gymnasts will compete on each apparatus - 3 best scores will count.
- No tie break - same colored medal
- All gymnasts of the team and 1 coach will be awarded

ALL AROUND COMPETITION

- To be classified for the All Around ranking the gymnast has to perform on all apparatus.
- Only 2 gymnasts per country will be classified in the All Around ranking.
- No tie break - same colored medal

APPARATUS FINALS

- 8 gymnasts : Max 2 per countries
- No tie break – same colored medal
- Apparatus finals rules (2 vaults)

GENERAL PRINCIPLES

- No filming & no mobile on the FOP
- Training suit on podium for medal ceremony
- The BIB number must be worn throughout the competition.

The following forms will be distributed:

- Inquiry form
- New element
- Request to change apparatus measurement
- Start list for WAG and for MAG
- Vault number
- Withdraw for final

SYSTEM OF PLAY

- The introduction of the scores by the judges will be by computer system.
- A panel will reflect each score.
- The established programme will determine the results.



5. DRAW

- The drawing of lots will be organized one month prior the event in presence of ISF Sport Department representatives / ISF Artistic Gymnastics TC president and members / FIG TC representative (virtual attendance).

6. PROTESTS AND APPEALS

- Inquiries shall be handled as per the latest FIG Technical Regulations 2025.
- Delegations may file verbal inquiries for the D score immediately after the publication of the score or at the very latest before the score of the following athlete is shown.
- A verbal inquiry must be confirmed in writing within four (4) minutes after it is made, and requires an agreement on the payment of an inquiry fee. USD 300 is required for the first complaint, USD 500 for the second, and USD 1,000 for the third and any of the subsequent complaints lodged by the same NOC throughout the event.
- Each inquiry will be verified by the Superior Jury, and a final decision (which may not be appealed) must be made.
